DATE	EVENT
15 December 2021	REGISTRATION OPENS. RELEASE of Official ILC Cup Rules and Competition Schedule. Rule Supplements, if any, will be posted as they become available.
15 January 2022	DEADLINE for Registration (Online Form) for all Teams and Submission of Team Roster: This is the last day on which teams may submit the names of their team members and advisors.
19 January 2022	RELEASE of the ILC Cup Problems for the Elimination Rounds. Four distinct problems shall be released, one for each pair of teams. ASSIGNMENT of Applicant/Respondent Memorial Sides. Each team shall be paired off and assigned a Problem.
04 February 2022	DEADLINE for Submission of Elimination Memorials. Memorials must be submitted to the Organizing Committee in accordance with the Official Rules.
21 February 2022	OPENING CEREMONY of ILC Cup 2021 (to be held online). The final schedule for the Elimination Rounds will also be announced at this time. EXCHANGE OF MEMORIALS. The Organizing Committee will be sending the opposing team's memorial via e-mail.
22 - 25 February 2022	ELIMINATION ROUNDS. Each Team will compete once as Applicant or Respondent, as the case may be, in a single-elimination knockout round.
27 February 2022	ELIMINATION ROUNDS WINNERS ANNOUNCEMENT (via the ILC Website and social media pages). The winning four teams of the Elimination Rounds will be announced.
28 February 2022	RELEASE of the ILC Cup Problems for the Semifinals. Two distinct problems shall be released, one for each pair of teams. Each team shall be paired off and assigned a Problem.
01 March 2022	DEADLINE for Top 2 Qualifiers to Submit their Choice for Either Applicant/Respondent Side for Memorials.

	ANNOUNCEMENT OF SIDES. The rest of the qualifiers will be informed of their assigned sides via email.
13 March 2022	DEADLINE for Submission of Semifinal Memorials. Memorials must be submitted to the Organizing Committee in accordance with the Official Rules.
14 March 2022	EXCHANGE OF MEMORIALS. The Organizing Committee will be sending the opposing team's memorial via e-mail. ANNOUNCEMENT of the Schedule for the Semifinals.
24 - 25 March 2022	SEMIFINALS. Each qualifying team will compete once as Applicant or Respondent, as the case may be.
27 March 2022	SEMIFINAL WINNERS ANNOUNCEMENT (via the ILC Website and social media pages). The 2 Teams that, based on their performance in the Semifinals, will advance to the Championship Round.
28 March 2022	RELEASE of the ILC Cup Problems for the Championship Round. ASSIGNMENT of Appellant/Respondent Memorial Sides.
14 April 2022	DEADLINE for Submission of Championship Memorials: Memorials must be submitted to the Organizing Committee in accordance with the Official Rules.
15 April 2022	EXCHANGE OF MEMORIALS. The Organizing Committee will be sending the opposing team's memorial via e-mail. ANNOUNCEMENT of the Schedule for the Championship Round.
29 April 2022	ILC CUP 2021 FINALS/CHAMPIONSHIP MATCH. The remaining 2 teams will compete as Appellant or Respondent, as the case may be, for the Championship.
30 April 2022	ILC CUP 2021 PRESENTATION OF AWARDS
